Show Grounds: American Sporthorse, 1177 Buena Vista Drive, Watsonville CA 95076 **Directions**: From Hwy 1, take the Buena Vista exit on the north side of Watsonville, turn west, the farm is 0.5 mile on the left. Gated entry to farm: push the black button by the keypad to open the gate automatically. Exiting: same policy but <u>the button to activate is at the top of the hill</u>, not down next to the gate. Gate stays open for only 30 seconds. If button doesn't work, use code 7285

Parking: All hauling vehicles continue down driveway <u>past the covered arena</u> to the field on LEFT. Follow the signs. Cars turn left at the first turn into parking lot or may use the field. Directions will be posted with ride times. Follow signage and please be careful not to block gates in/out for other big trailers.

<u>Entries</u>: Entries will be accepted in first-come basis until show is full, additional entries will be accepted to fill scratches without a post entry fee. Post entries considered during show only as space may allow with \$20 post entry fee added. Any entry received after the closing date will be assessed a \$20 per ride late charge if accepted. <u>Entries must include all required fees, membership proofs/copies, signatures and payment.</u> If you have questions on fees for any competition, please call management for clarification. No phone entries for recognized shows. Emailed or faxed entries will incur an additional \$20 service fee. Numbers will not be released until entry is <u>complete</u> and payment received. <u>Checks payable to American Sporthorse Shows</u>. If we have to find and print out your cards for you, a \$15 PITA fee will apply.

OPPORTUNITY CLASSES: Must pay office fee and CA drug fee. Exempt from horse and rider membership fees *if only entered in Opportunity classes*. If a CDS member, these classes <u>do count</u> towards CDS program (RAAC qualifying, Year End Awards, etc) but <u>do not</u> for USDF or USEF awards. You may cross enter into non-Opportunity classes but then all membership numbers and fees are required. See GR 821 for details.

<u>Mail all entries to: 1177 Buena Vista Drive, Watsonville, CA 95076</u>. Shows close 7 days before show, the entry must <u>be in our hands</u> one week before show. Returned checks will incur \$50 NSF fee and must be cleared with cash, certified check or money order. Scratches received before closing date will be refunded less a \$25 processing fee. Scratches on or after closing date are NOT eligible for refund unless ride times are filled from a wait list. If the show is cancelled due to weather or other emergency, 50% of fees will be refunded.

Every class offered herein is covered by the rules and specifications of the current USEF Rule Book and will be conducted and judged in accordance therewith. These shows follow all current USEF rules and use current USEF/USDF/FEI dressage tests (and USEA/WDAA tests for schooling shows), it is the competitor's responsibility to be informed.

FREESTYLES: Include proof of eligibility with entry, we use regular CD music format. Sound check at lunch break or before show starts. Class 24 does not include Training Level FS.

All classes offered including USEA and WDAA classes. If you want to ride a test not listed, just ask!

Ride times: Emailed to competitors 2-3 days before the show, may be updated; <u>double check your email for</u> <u>times by noon the day before the show</u>. They will be final by noon the day before the show and posted at the showgrounds. We try not to do large shifts unless many scratches leave big holes in the schedule. It is the exhibitor's responsibility to contact the organizer (831-247-5584) if unable to access the times online or via email. <u>PLEASE make sure your email is legible on your entry!</u>

Show Attire: Show attire per USEF rules will be required at recognized shows. Schooling shows require a minimum of approved safety helmet and boots or paddock boots/half-chaps, informal attire permitted.

Awards: Ribbons 1st to 5th, horse appreciation goodies for all, glassware or other prizes for 1st place. High score award for each show, series high score trophy awarded at the last show to the highest scoring ride of the series. Awards and tests are picked up at the awards table. No mounted awards.

Stabling: Permanent stabling in 12'x16' stalls with solid doors and rubber matted floors @ \$65/night, initial and added shavings included in stall fee. Bring your own feed & water buckets and mucking tools, wheelbarrow available. Check on availability, 12 stalls available in show barn. 2 oversized separate stallion stalls also available.

Accommodations: Many hotels in 10-20 minute drive from show grounds. Motel 6: 831-728-4144 (allows pets); Holiday Inn Express 831-728-3600; Days Inn, 831-740-4520; many more available. Review more options on our website at www.in-balance.com, or search online for Watsonville or Aptos areas.

Arenas/Footing: Footing is excellent sand/synthetic and dust-free and similar in both arenas. Warm up is covered arena 23m x 60m, main show arena is outside. Standard 20m x 60m arena for all classes except USEA tests designed for short court (offered only at schooling shows).

Dogs: Leave your dogs at home or in/at your vehicle, NOT permitted on leash on the grounds.

Test Calling: We have a PA system/microphone for music and calling tests (occasionally a passing airplane or helicopter from nearby airport can causes an unamplified reader to be unhearable). Our announcer is willing to call your test (simply ask them as you enter the arena) or your caller may use the PA system.

Freestyles: Standard CD format for music, not MP3. Sound check available during breaks in show, contact announcer. Know your eligibility requirements and submit proof of qualifying ride with entry. Quadrilles and Pas de Deux: Each horse must have separate entry and pay required individual fees, only one entry fee is required per team. USDF and USEF exemptions apply.

Lunging: <u>*Very limited*</u>. Allowed in the covered arena only if the warm-up arena is vacant or with the consent of other riders present.

Food: Food, drinks and coffee are available throughout the show day at the show office.

USEF MEMBERSHIP STATEMENT Life, senior active and junior active members shall be eligible to participate in all classes at Regular Competitions, Eventing Competitions at the Preliminary Level or above and Combined Driving Competitions at the Advanced Level, Dressage, Reining and Vaulting Competitions and Endurance Rides. A nonmember may participate as a handler, rider, driver, owner, lessee, agent, coach or trainer at Regular Competitions, Eventing Competitions, Dressage Competitions, Reining Competitions and Combined Driving Competitions upon payment of a \$45 Show Pass fee. Participants in the following classes are exempted from the Requirements of this rule: 1) leadline; 2) exhibitions; 3) games and races; 4) classes for 4-H members; 5) walk trot and academy classes (academy classes are classes limited to horses used regularly in a lesson program); 6) USDF introductory level tests, pas de deux and quadrille classes; 7) NRHA Endorsed Reining Competitions. 8) Opportunity classes, 9) citizens of other nations who have proof, in English, of current membership in good standing of their own National Federation, 10) USEA beginner novice division; and 11) assistant handlers in Dressage Sport Horse Breeding classes.

Every person participating in any competition recognized by the Federation is subject to the Federation Bylaws and Rules including the provisions of Chapters 6 and 7 and is responsible under the rules for their own acts and failures to act and for the acts and failure to act of their agent or agents whether or not they or their agent or agents have signed an entry blank.

Minors who do not have a valid driver's license which allows them to operate a motorized vehicle in the state in which they reside will not be permitted to operate a motorized vehicle of any kind including, but not limited to, golf carts, motorcycles, scooters, or farm utility vehicles on the competition grounds of recognized competitions. Minors who have a valid temporary license may operate the above described motorized vehicles as long as they are accompanied by an adult with a valid driver's license. Violators of this rule will be cause for sanctions against the parents(s), guardian(s) and/or trainer(s) who are responsible for the child committing the offense. Penalties may include exclusion of the child, parent(s), guardian(s), and/or trainer(s) from the competition grounds for the remainder of the competition and charges being filed against any of the above individuals in accordance with Rule 6. Wheelchairs and other mobility assistance devices for individuals with disabilities are exempt from this rule.

Sharps: In accordance with the rules of USEF Bio-Hazardous Medical Waste containers are provided at the show office and stabling area. All exhibitors and their agents are responsible for the proper disposal of this waste.



Vaccination Notice: Exhibitors are reminded of USEF's vaccination policy, effective 12/1/15; see GR845 for details. You can obtain the form from USEF at https://www.usef.org/documents/membership/ EquineVaccinationRecord.pdf. The completed form, signed by your veterinarian, should be included with your entry. If you select an alternative option under the rules, please bring required documentation. In accordance with the rule, competition management has the right to review vaccination documentation for every entry. Non-compliant entries may be quarantined or denied permission to unload, and will not be allowed to compete nor to mingle with other horses. *No refunds will be given if right to compete is denied because the vaccination documentation is missing or incomplete*.

Series High Score award by level: Must compete in <u>at least 2 of the recognized shows</u> to be eligible for award, highest score at each level wins a pair of Euro Pro wash n' wear boots. Highest score of the season wins perpetual trophy. Schooling show scores DO COUNT towards awards but not eligibility.

PRE HIGH SCORE AWARD: Sashes and polo shirts awarded by rider division. Horse must be PRE, owner or rider must be members of USPRE. Sponsored by USPRE. Details posted at show office.

4/27/2018: <u>AQHA recognition for all USEF-rated shows has been added</u>, riders must be AQHA members to earn points at these shows. Results will be submitted.



2018 Great American Insurance Group/USDF Regional Dressage Championships

A single Regional Dressage Championship program organized by the United States Dressage Federation (USDF), and recognized by the United States Equestrian Federation, Inc. (USEF), will be held in each of the nine USDF regions. In addition, Alaska and Hawaii may each hold state championships if an official request from a Group Member Organization (GMO) is received by April 1 of the prior year. The Regional Championship Program Rules can be found on the USDF website at <u>www.usdf.org</u>. Please refer to the 2018 USDF Member Guide for the comprehensive list of rules and requirements for this program.

Membership/Registration Requirements for Qualifying and Championships

All memberships and registrations/recordings must be correct and current at the time qualifying scores are earned and at the time of the championships. Rider:

Must have a USDF Participating* Membership (PM).

- Must have a USEF membership (Junior Active, Senior Active, or Life).
- Horse:
- Must have a USDF Lifetime Horse Registration (LHR).
- Must have a USEF (Annual or Lifetime) Horse recording.
- USDF horse registration and USEF horse recording must be in the name(s) of the current owner(s) or lessee(s) of record. A horse is not required to have breed registry papers.

Owner:

- Must have a USDF Participating or Business Membership and a USEF membership (Junior Active, Senior Active, Life, or Recorded Farm (with Active Farm Owner)). If the horse has more than one owner, at least one owner must have both active USEF membership and active USDF Participating or Business Membership. For a business or farm to be the valid owner under this requirement, it must be listed as an owner of the horse with both USEF and USDF.
- * PMs are USDF members who join USDF directly. USDF Group Members (GM) are ineligible.

Minimum Qualifying Scores: One set of nationally-standardized qualifying scores has been established for all USEF/USDF Regional Championships, for Training Level through Grand Prix, in three divisions: open, adult amateur and junior/young rider. FEI Junior and FEI Young Rider classes have only one respective division. Freestyles have only open divisions.

Regional Adult Amateur Equitation Program

The USDF Regional Adult Amateur Equitation Program recognizes adult amateurs competing in equitation and promotes correct seat, position, and use of the aids in dressage. An Adult Amateur Equitation Regional Final dass will be held in conjunction with each of the nine USDF Regional Dressage Championship competitions, providing adult amateurs with additional opportunity for recognition.

Adult amateurs wishing to qualify to compete in an Adult Amateur Equitation Regional Final may do so by meeting the following requirements.

Qualifying Requirements

- To be eligible for the USDF Adult Amateur Equitation Regional Final class, rider must have
 - a) Earned a score of 70% or higher in any dressage seat equitation class (except walk/trot) at a USEF/USDF-recognized Dressage competition within the qualifying period of the applicable regional championship.

or b) Qualified to compete in any regional dressage championship class (excluding freestyles).

Membership Requirements

- Rider must have a USDF Participating Membership at the time the qualifying score is earned, and at the time of the Regional Final class.
- Rider must be an adult amateur, in accordance with GR1306 of the USEF rules, and be designated with USEF as an adult
 amateur when the score is earned, and at the time of the Regional Final class.
- Owner must have a USDF Participating or Business Membership when the qualifying score is earned, and at the time of the Regional Final class.
- Horse must have a USDF Lifetime Horse Registration when the qualifying score is earned, and at the time of the Regional Final class.

USDF Statement on Animal Welfare

The United States Dressage Federation, Inc. (USDF), a federation of over 100 independent organizations throughout the United States with a membership of nearly 30,000 members, supports the concept of ethical treatment of animals.

Dressage is a classical method of training horses, based upon the horse's natural responses, as carried out in a gradual, planned program during which the horse's athletic abilities are improved in a systematic manner. As a result, the horse becomes capable, confortable, and responsive in partnership with the rider without the use of force. Dressage competition at various levels of achievement is the ultimate test of the training program to determine whether the desired harmony between horse and rider has been achieved.

The rules pertaining to dressage competition prohibit the use of artificial appliances, training aids, and drugs, which would force the horse to submit. Instead, the emphasis is upon training and a cooperative partnership with the rider. Major competitions are carefully monitored to assure that there is no unnecessary force or harshness displayed.

Unlike other horse sports in which horses enter training at a relatively immature state, dressage training is usually not seriously begun until the horse is three or four. The top levels of achievement require five or more years of progressive training and it is not unusual to see horses in international competition in their late teens. This, in itself, places a premium on good care and soundness throughout the horse's life.

While supporting the concept of animal welfare in its broadest form, the United States Dressage Federation, Inc., also recognizes that it is unrealistic to ascribe human emotions and responses to the horse which in its wild state is a creature of flight, living a hard and precarious esistence. Under domestication, the horse is assured of ample food, water, and shelter, as well as protection against infectious diseases and damaging parasites, thus leading a longer and healther life with a high rate of survival.

As an educational organization, U3DF has numerous programs, which teach people how to pursue the accepted, humane training methods. A program of certifying instructors also emphasizes protecting the horse's welfare in pursuit of dressage training.

Each competitor is responsible for supplying management with correct applicable numbers (USDF and USEF) for horse, owner, rider, and trainer, before the day(s) of the competition.

The scores of competitors who fail to supply correct numbers may not be counted toward national awards. USDF Membership Benefits: USDF is dedicated to education, the recognition of achievement, and promotion of dressage. For details er benefits, including educational programs, awards, and other opportunities, refer to the USDF Member Guide or the USDF website at www.usdf.org



Membership Requirements for USEF-licensed/USDF-recognized Competitions; Owners and riders, including foreign riders and owners who are not residents of the US, wishing to participate in a USEF-licensed/USDF-recognized competition as a net ownerlessee, must have either a USDF Group Membership (GMM), Participating Membership (PMM), or have a USDF Mowlember (N) mber (NM) identification number and pay the USDF Non-Member (NM) iee. (Note: USDF Business Nembers can own horses but cannot compete as inders with their USDF Business Membership.) Individuals cannot compete at a USEF-licensed/USDF-recognized competition with a USDF Education Membership.

Horses competing at USEF-licensed/USDF-recognized competitions must have either a USDF Horse Identification (HID) number or a USDF Lifetime Horse Registration (LHR). Proper credentials or verification certificates must be presented to the competition secretary.

Riders and owners wishing to participate in a USEF-licensed/USDF-recognized competition, and not able to present the competition secretary with verification of a USDF membership or Nuk identification, and USDF LHR or USDF HID, must complete a USDF Competition Afridavit Form and pay the \$5 afridavit filing lee. A copy of a completed afridavit form from another competition may also be used for verification purposes for up to 60 days. (Exception: Afridavits cannot be used at Great American Insurance Group/USDF Regional Dressage Championships.) Exceptions:

- Horses competing only in Individual Breed Classes (IBCs) at DSHB competitions, sires and dams of horses in DSHB group classes, where the se sires or dams are not actually competing in the same competition, horses competing only in breed restricted dressage or DSHB classes at Regular Competitions (e.g. all Arabian, all Friesian, or all Morgan classes), or in USDF Introductory Level tests, pas de deux or quadrille, are exempt from this requirement. Als exempt are horses ridden in leadline, exhibitions, games and races, classes for 4-H members, walk-trot, academy, and opportunity classes.
- Riders and owners/lessees competing only in classes which are exempt from the USDF HID requirements are also exempt from the USDF NM identification number and NM fee requirements. Also exempt are handlers of horses competing in DSHB In-Hand or Group classes.

An HID number can be upgraded to a Lifetime Horse Registration (LHR) for a fee of \$00. If a horse has a USDF LHR it does not need an HID number. An HID number is a one-time fee that does not need to be renewed. Lifetime Horse Registration (LHR): A horse with an LHR (\$115) is eligible for AdequamPUSDF Year-End Awards, and eligible to compete at USDF Breeders Championship Series Finals and Great American Insurance Group/USDF Regional qualifying and championship classes, assuming requirements for the owner and nider are met. If a horse has an LHR it does not need an HID number. An LHR does not need to be renewed.
